3. In view of the above, **all the interested / eligible Insured Persons (IPs) are advised to ensure that their personal/family/dependent data is correct in the IP portal.**
4. **The personal details of dependent (for whom the 'Ward of IP Certificate' is required) must be correct/match with NEET (UG) -2023 application form.**
