**Admission of 'Ward of Insured Person (IP)' in UG Course (MBBS / BDS) and B.Sc Nursing Course in ESIC Education Institutions & some Government Medical Colleges under 'Seats Allocated for Ward of IP' for Academic Session 2024-25.**

1. Applications will be invited from eligible 'Ward of Insured Person' (IP) under ESI Scheme for admission in UG Course (MBBS / BDS) & B.Sc Nursing Course in ESIC Educational Institutions and some Government Medical Colleges under 'Seats allocated for Ward of IP' for academic session 2024-25 as per admission policy and procedure.
2. Eligibility conditions and Number of seats for ESIC Ward of IP will be published (in the detailed Admission Notice) on ESIC Website (i.e. [www.esic.gov.in](http://www.esic.gov.in)) under 'Admission' link in due course of time.
3. Applicants are advised to visit / check the ESIC ([www.esic.gov.in](http://www.esic.gov.in)) and DGHS / MCC ([www.mcc.nic.in](http://www.mcc.nic.in)) website regularly for further details / instructions.

4. The online link will be given through Insured Person (IP) Portal login / tab / window available at ESIC Website ([www.esic.gov.in](http://www.esic.gov.in)).
5. In view of the above, **all the interested / eligible Insured Persons (IPs) are advised to ensure that their personal / family / dependent data is correct in the IP portal.**
6. **The personal details of dependent (for whom the 'Ward of IP Certificate' is required) must be correct / match with NEET (UG) - 2024 application form.**
7. Candidates will be allotted seats, based on their merit cum preference of Institutions, through a centralized online counselling to be conducted by Directorate General of Health Services (DGHS) / Medical Counselling Committee (MCC).
8. All process / actions undertaken regarding admission under 'Seats allocated for ward of IP' for 2024-25 would be subject to final outcome in WA 2274 & 2304 of 2019 before the Hon'ble High Court of Madras.
