OFFICE MEMORANDUM

Subject: Delegation of Powers in respect of Medical Commissioners at Hqrs- reg.

Delegation of powers of Medical Commissioner, ESIC was approved in 2005. Since then the number of posts of Medical Commissioner has increased from one to five at Hqrs. The activities of the Corporation have also expanded manifold. So, there was need for revision of DoP of Medical Commissioners. Accordingly, a committee was constituted under the chairpersonship of Financial Commissioner. On the basis of recommendations the Committee, the revised Delegation of Powers in respect of Medical Commissioner (Medical Administration), Medical Commissioner (Medical Services), Medical Commissioner (AYUSH), Medical Commissioner (Medical Education) and Medical Commissioner(Procurement), has been approved by Competent Authority and are enclosed herewith.

Whereas as per Sub-Rule (2) of Rule 16 of Employees' State Insurance Corporation (Central) Rules 1950 and Rules of Business (File No. 4-1 (1y68 (O&M)) dt. 29.06.1968, amended from time to time, empowers the Director General to further delegate powers.

In exercise of powers conferred to the Director General, ESIC, being the Head of Department, hereby, has delegated the powers further to the officers in the post of Medical Commissioner (Medical Administration), Medical Commissioner (Medical Services), Medical Commissioner (AYUSH), Medical Commissioner (Medical Education) and Medical Commissioner(Procurement), as enclosed. The delegated powers will be exercised in conformity with the general provisions of the relevant Rules.

The delegated powers will be exclusive for the above mentioned officers and cannot be further delegated.

This issues with the approval of the Competent Authority.
