**Subject: - Allocation of budget under ARM/SR for Revised Estimates 2023-24 and Budget Estimates 2024-25-reg.**

Sir/Madam,

I am directed to inform that the Standing Committee has approved the allocation of a sum of Rs. 37653.40 lakhs and Rs. 11996.60 lakhs under the Sub – Head “Hospital/Dispensary” and “Office Building” respectively for the purpose of ARM and a sum of Rs. 33011.13 lakhs and Rs.8966.98 lakhs under the Sub – Head “Hospital/Dispensary” and “Office Building” respectively for the purpose of SR during the year 2023-24. Likewise, a sum of Rs. 54851.13 lakhs and Rs. 15992.39 lakhs has been allocated under the Sub-head “Hospital / Dispensary” and Office Building” respectively for the purpose of ARM and a sum of Rs. 59200 lakhs and Rs. 17015.45 lakhs under the Sub – Head “Hospital/Dispensary” and “Office Building” respectively for the purpose of SR during the year 2024-25. The Region Office / Hospital wise distribution of this amount has been shown in the enclosed statement (Annexure- ‘A’ & ‘B’).

2. You are requested to sanction and release the funds under your delegated powers in accordance with the with the detailed guidelines issued from time to time. The request/indent for transfer of funds so sanctioned should be sent directly to Finance & Accounts II at Hqrs’ Office under intimation to Property Management Division. It may please be ensured that the funds are remitted to the maintenance agencies at the earliest possible.

3 . Further, if there is any demand under ARM/SR for revised budget you may send your demand with all details and justification for such additional demands by 31stAugust 2024. No further request for ARM/SR will be entertained after that period and the present allocation would be treated as final.

4. The allocation is subject to approval of the revised estimates 2023-24 and budget estimates 2024-25 of ESI Corporation from the Central Govt.If there is any urgent addition requirement of ARM/SR funds for 2024-25, the same may be intimated with all details / justification to Hqrs. Office for consideration/allotment.
