4.5.3	List of completed schemes/ projects/ Programmes ESIC Covid-19 Relief Scheme	Fully Met	<p>The ESIC Covid-19 Relief Scheme was introduced for those Insured Persons who were employees under Section 2(9) of ESI Act, 1948, to provide relief to their dependents in case of death of Insured Person due to Covid-19.</p> <p>This scheme was valid for period of 2 years, w.e.f. 24.03.2020, upto 23.03.2022.</p> <p>The Insured Person who died due to Covid-19 disease during above-mentioned period, must have been registered on ESIC online portal 3 months prior to date of diagnosis of Covid-19 disease, and he/she must have been in employment on the date of diagnosis, with contribution for at least 35 days should have been paid or payable in respect of him/her during the period of maximum 1-year preceding the diagnosis.</p> <p>The relief to be paid under the scheme was calculated as 90% of average daily wages of the deceased IP, similar to Dependent's Benefit under ESI Act, 1948.</p>
			<p>1.) Atal Beemit Vyakti Kalyan Yojana (ABVKY):</p> <p>This scheme is a welfare measure for employees covered under Section 2(9) of ESI Act, 1948, who were rendered unemployed, in the form of relief payment upto 90 days, once in a lifetime. The Scheme was introduced w.e.f. 01-07-2018 on pilot basis for a period of two years initially.</p> <p>Later, in the wake of lockdown due to Covid-19 disease leading to increased cases of unemployment, the scheme was eventually extended and the eligibility conditions were relaxed.</p> <p>The rate of unemployment relief under the scheme was enhanced to 50% of wages from</p>

Rajiv Gandhi Shramik Kalyan Yojana</p>	Partially Met	<p>earlier rate of 25% along with other relaxation in eligibility conditions. As per relaxed conditions, the Insured Person should have been in insurable employment for a minimum period of one year immediately before her/his unemployment and should have contributed for not less than 78 days in the completed contribution period in 12 months immediately prior to unemployment, while prior condition required minimum period of 2 years of insurable employment and 78 days contribution each in preceding 4 contribution periods.</p> <p>The scheme has now been extended upto 30 June, 2024. The relief shall become due for payment after 30 days from the date of unemployment and claim can be submitted directly to the designated ESIC Branch Office by the worker. Claims to get the relief can be made online at website www.esic.in along with submission of the physical claim with an affidavit, photocopy of Aadhaar Card and Bank Account details to the designated ESIC Branch Office by post or in person.</p> <p>2.) Rajiv Gandhi Shramik Kalyan Yojana:</p> <p>This scheme of Unemployment allowance was introduced w.e.f. 01-04-2005. An Insured Person who becomes unemployed after being insured in insurable employment for two or more years, due to closure of factory/establishment, retrenchment or permanent invalidity not less than 40% arising out of non-employment injury are entitled to :-</p> <ul style="list-style-type: none"> • Unemployment Allowance equal to 50% of wage for a maximum period of upto Two Years during the life time. • Medical care for self and family from ESI Hospitals/Dispensaries during the period IP receives unemployment allowance. • Vocational Training provided for upgrading skills - Expenditure on fees/travelling allowance borne by ESIC.
