Sub: Consideration of cases for grant of financial up-gradation under Modified Assured Career Progression (MACP) Scheme in respect of Non-Medical officers – regarding.

I am directed to refer Estt.-I Branch, Hqrs. Circular No. A-33/13/1/2018 -E.I dated 27.02.2024, vide which it was requested that proposal may be forwarded for consideration for grant of financial up-gradation under MACP Scheme in respect of eligible Officers/Officials in Group 'A', 'B' and 'C' (SSO only) which are going to mature by 30th June 2024 or have already been matured, after due verification of service record and other particulars in the prescribed proforma. Director (Fin.)/Assistant Director (Fin.) to this office at the earliest. If there is no eligible case for the relevant period, a NIL report may be sent to this office.
