## MEMORANDUM

<b>Subject :</b>	<b>Revised guidelines relating to implementation of ESIC Pensioner Medical Scheme-2006- Clarification with regard to FMA.</b>

Various references have been received in which clarification has been sought by this Office that as per Point No.A1 and A3 of the Revised Guidelines relating to implementation of ESIC Pensioners' Medical Scheme, 2006, pensioner is required to refund the Fixed Medical Allowance for re-entry in ESIC-PMS but actual date from which FMA is to be refunded is not clear.

In this regard, it is stated that as per Revised Guidelines issued Pensioners can be re-admitted one more time after paying a registration fee of Rs.30 and refund of the FMA received by him. The refund of FMA by the pensioners shall be applicable from the date of issuance of the Revised Guidelines i.e. 25<sup>th</sup> May, 2021 for re-entry into the Scheme.
