Sub: Guidelines for special provisions to ESIC pensioners aged 80 years and above under ESIC Pensioners' Medical Scheme, 2006 – Reg.

Sir,

Consequent upon issuance of circular No. Z-16025/98/2017-CGHS-III dated 11.7.2017 by Ministry of Health & Family Welfare on the above subject, the issue was examined by this office for adoption of the same for the pensioners of ESIC aged 80 years and above covered under ESIC-PMS-2006. Accordingly, following guidelines are issued for ESIC Pensioners aged 80 years and above :

1. Consultation of Doctor at ESIC Dispensary / hospital without standing in queue.
2. ESIC Doctors (who is on duty or available) shall enquire by phone, at least once in a month to enquire about their well-being / make a home visit if residing within 5 Kms of ESIC Dispensary / hospital.

{Modalities may be decided by respective units depending upon the local conditions / requirements.}

3. Settlement of medical claims on priority out of turn.
4. Follow-up treatment from same specialist in non-empanelled hospital from where he/she was earlier taking treatment as a special case in view of advanced age and difficulty to change physician subject to the reimbursement limited to CGHS rates and collection of medicines as per ESIC / CGHS guidelines.

This issues with the approval of Director General.
