**Sub: *ESIC Pensioners Medical Scheme, 2006 – rates of contribution.***

Sir,

Consequent upon implementation of the report of the 7<sup>th</sup> Pay Commission and revision of pay scales and pension, CGHS has revised the rates of subscription applicable to the Central Govt. pensioners. ESIC-PMS-2006 is primarily based on the CGHS rules and the rates of subscription and entitlements in the Scheme are also similar to those applicable to CGHS beneficiaries. Therefore, in supercession to all earlier instructions on the subject, the following revisions are being made for the pensioners covered under ESIC-PMS-06, in so far as it relates to the facilities mentioned below:-

**(A) Monthly Contributions for availing ESIC facility by ESIC Pensioners:**

S.No.	Corresponding levels in the Pay Matrix as per 7 <sup>th</sup> CPC	Contribution (Rupees per month)
1.	Level : 1 to 5	250/-
2.	Level : 6	450/-
3.	Level : 7 to 11	650/-
4.	Level : 12 & above	1000/-

**(B) Entitlement of wards in private hospitals empanelled under ESIC:**

S.No.	Corresponding Basic Pay drawn by the Officer in 7 <sup>th</sup> CPC per month	Ward entitlement
1	Upto Rs. 47,600/-	General
2	Rs. 47,601/- to Rs. 63,100/-	Semi-private
3	Rs. 63,101/- and above	Private

**(C) Pay slab for determining the entitlement of accommodation in AIIMS, New Delhi:**

S.No.	Corresponding Basic Pay drawn by the Officer in 7 <sup>th</sup> CPC per month	Ward entitlement
1	Upto Rs. 63,100/-	General
2	From Rs. 63,101/- to Rs. 80,900/-	Private
3	Rs. 80,901/- and above	Deluxe / Private

- 2) Reference to pay in this order relates to the pay drawn in the level of pay.
- 3) Pensioners have an option to get their ESIC medical card made by either making contribution on an annual basis (twelve months) or by making contribution for 10 (ten) years [120 (one hundred and twenty months)] for getting a pensioner card with life-time validity. Further clarification are as follows:-
  - (i) Pensioner beneficiaries, who have already obtained ESIC card with life time validity by paying a lump sum amount equivalent to 10 years' contribution, will not be required to pay any additional amount as a result of the revision in the rates of contribution for availing ESIC facility.
  - (ii) Entitlement of pensioners/family pensioners who have already deposited their contribution for life time ESIC facility, will not be changed.
  - (iii) Pensioners who are making contributions on an annual basis are required to pay their contributions well before the expiry of the validity period of the card. For this purpose, all card issuing authorities are required to issue reminders to the pensioner intimating about the date well in advance.
  - (iv) Pensioners/family pensioners who are contributing to the ESIC on an annual basis and wish to continue to avail benefits under the Scheme will have to contribute at the revised rates upto the time of contribution needed to cover a period of a total of ten years from the

time pensioner ESIC card was issued for the first time to them. The revised rate of contribution for the remaining period would be with reference to the level of pay that he/she would have drawn in the post held by him/her (at the time of his/her retirement/death) had he/ she continued to be in service now but for his/ her retirement/ death.

(v) Any pensioner/ family pensioner who is entitled to avail ESIC facility has not so far got his/ her pensioner ESIC card made, the rate of contribution in such cases will be with reference to the level of pay that he/ she would have drawn in the post held by him/ her (at the time of his/her retirement/ death) had he/ she continued to be in service now but for his/ her retirement/ death.


(vi) These instructions are effective from 1/2/2017. Employees superannuated on or before 31/1/2017 and had submitted their application on or before 31/1/2017 may be allowed the subscription at the prevalent rates applicable as on 31/1/2017 vide O.M dated 20/5/2009 of Min. of Health & Family Welfare, adopted in ESIC vide circular dated 7/1/2010. Pensioners applying for ESIC pensioner card on annual / lifetime basis after 31/1/2017 will have to pay as per the above revised rates effective from 1/2/2017.

This issues with the approval of Director General in concurrence with the Financial Commissioner.
